Estates After an Unexpected Death


When a death is unexpected, it can be difficult to know where to start the process of handling the estate. You may be trying to determine if there was a will or searching for an estate attorney.



If there was not a will that appoints a **personal representative** to oversee the administration of the estate, you will have to go to probate court to get a **personal representative** named.


Often, the details of handling an estate can delay family members from dealing with a wrongful death suit. However, it's important not to wait too long to file a wrongful death suit.

Understanding the Role of Family

There may be confusion about which family member should take the lead in handling a wrongful death case or which family members can recover damages.



The person named as personal representative to oversee the estate is the person who would file a wrongful death claim or lawsuit on behalf of the people who may recover damages in a wrongful death case.

South Carolina law states that the following people may recover damages in a wrongful death case:

- The surviving spouse and children of the deceased person.
- The surviving parents of the deceased person, if there is no spouse or child.
- The heirs of the deceased person, if there are no parents, spouse, or children.

Do I Have a Wrongful Death Case?

How do you know if you have a wrongful death case?

Wrongful death claims involve all types of fatal accidents, from simple car accidents to complicated medical malpractice or product liability cases.

Persons, companies, and governmental agencies can be legally at fault for acting negligently and for acting intentionally.







A wrongful death suit must meet the following criteria:

- You must prove that the death occurred because of someone's negligence or wrongful conduct. Negligence means the person failed to act as a reasonable person would have acted.
- You must show the extent of the loss to the heirs of the person who died.



Should I Pursue a Wrongful Death Suit?

Some families feel the process of a wrongful death suit may extend the pain and grief of the loss. They do not want to focus on the details of their loved one's death.Other families want to be sure someone is held responsible for the death. Still others simply cannot afford the medical bills, funeral expenses, or loss of income created by the death of a loved one.

Each family must decide what is right for their individual situation.

What is My Case Worth?

There are many different factors to consider in each wrongful death case. The amount of compensation is affected by:

The amount of money the deceased would have provided to survivors if he or she hadn't died, including loss of expected earnings; loss of benefits such as health insurance or pension plans; and the value of goods and services that a victim would have provided.

Family members may also be awarded money for mental
shock and suffering, grief and sorrow, loss of companionship, and reasonable funeral expenses.

The amount of medical expenses connected to the death (which may be awarded under a survival claim).

Should I Talk to the Insurance Company Without An Attorney?

Dealing with an insurance company may not be as straightforward as it seems. Remember that the goal of the insurance company is to settle the case quickly and for as little as reasonably possible.

There are several guidelines to keep in mind when dealing with an insurance company.

You do not have to accept the settlement offered to you or sign forms sent to you.

An attorney can help you determine if the settlement offered is a reasonable one.



The insurance company has investigated the details and circumstances of your loved one's death, but they may not share all the information gathered with you.

An experienced wrongful death attorney will also investigate the case and provide you with all the details. Often, these details can affect the amount of a settlement.



First Steps in Filing a Case

A wrongful death case must be filed by the **personal representative** or **administrator of the deceased person's estate**. The first step is to get someone appointed to that role through probate court.



The cause of the death has to be investigated. This may include obtaining medical records, interviewing witnesses, and getting the medical opinion of an expert.



Once it is determined the death was caused by the negligence or wrongful actions of another person, a company, or agency, a wrongful death case may be filed.
